The University of Lagos is once again faced with the perennial problem of accommodating its old and in-coming students in Halls of Residence. Old and prospective students of this University are hereby notified that accommodation of students for the 1979-80 Session will be according to the following order of priority subject to availability of space.

- (a) All Final Year Full-Time students
- (b) Foreign students whose parents or relations are resident outside Lagos
- (c) Students Union Executive
- (d) Outstanding University Sportsmen and women
- (e) Fresh undergraduate and post-graduate student including prelim. (Only few places are available).

2. All Second-Year students are required to make their own arrangements for accommodation off campus.

3. Students offered admission for the 1979-80 Session may apply for accommodation in the Hostel to the Deputy Registrar (Students). Such students requiring accommodation should state in full their Names, Sex, Residential addresses, Faculty, Proposed Course of Study, State of Origin and Marital Status.

4. Successful candidates will be informed, while those who do not hear from us before the beginning of the session are advised to make their own accommodation arrangements in Lagos.

5. Admission to the University does not guarantee a place in the Halls of Residence.

6. Since University hostels are not designed for single room accommodation, all students for whom accommodation is provided will be required to share rooms. Squatters and illegal lodgers in Halls will not be tolerated. The University accepts no responsibility for any student who moves to the campus without ensuring first that accommodation has been allocated to him/her.

7. The University warns all students and parents that it is extremely dangerous for a student to move into Lagos unless proper and firm arrangements
