In the Matter of Section 5 of the Trade Disputes (Essential Services) Decree

AND

In the Matter of a Trade Dispute between the Association of Senior Staff of Banks, Insurance and Financial Institutions and the Nigeria Employers' Association of Banks, Insurance and Allied Institutions

To inquire into the dispute notified by the Nigeria Employers' Association of Banks, Insurance and Allied Institutions against the Association of Senior Staff of Banks, Insurance and Financial Institutions over the following points:—

(i) Failure on the part of the Union to comply with the terms of the Recognition and Procedural Agreement entered into by both Parties.

(ii) The Union's attempt to unilaterally set aside this Agreement by deliberately misinterpreting Article "5"; Appendices "A" and "C" of the said Agreement.

(iii) The Union unlawfully embarked on "go slow" and "work to rule" which caused disruption to the business of the United Bank for Africa Limited without complying with the terms of Recognition and Procedural Agreement.
