(v) Giving instruction on management subjects, training strategies and presentation skills ;

(vi) Performing such other related duties as may be assigned.

(c) *Senior Management Development Officer*

(i) Leading a training team and individual sessions of a training seminar ;

(ii) Selecting and determining learning strategy and methodology ;

(iii) Selecting and developing audio-visual materials and devices ;

(iv) Preparing and adapting lesson plans ;

(v) Identifying and recommending resources for training seminars ;

(vi) Composing course descriptions for specific pre-seminar publicity purposes ;

(vii) Developing selection criteria for participants and assisting organisation to select participants based on these criteria and learning objectives ;

(viii) Conducting formal training at seminars and designing seminar modules.

(ix) Refining and revising module objectives and materials based on direct and indirect evaluation results ;

(x) Identifying pre and post-training performance levels.

(d) *Chief Management Development Officer*

The Chief Management Development Officer as the Head of the Management Development Division of the Department shall be responsible to the Permanent Secretary in the performance of the following duties :

(i) Directing and co-ordinating training programmes in the State Public Service ;

(ii) Preparing budget inputs to Government for Management Development projects ;

(iii) Advising on proposed legislation policies, circulars and directives affecting training programmes ;
