

Whereas Goddey Adesosu, having been duly convicted under the Indian Hemp Act, 1966, was sentenced to 10 years imprisonment;

AND WHEREAS the said GODDEY ADEBOSU has served a portion of the said sentence;

AND WHEREAS after consultation with the Council of State, I am pleased to remit the remainder of the said sentence;

Now, Therefore, in exercise of the powers conferred by section 161 (1) of the Constitution of the Federal Republic of Nigeria, 1979, and of all other powers enabling me in that behalf, I, Shehu Usman Alivu Shagari, President of the Federal Republic of Nigeria, Commander-in-Chief of the Armed Forces of the Federation, do hereby remit the unexpired portion of the sentence-imposed on the aforesaid Goddey Adebosu.

AND WHEREAS after consultation with the Council of State, I am pleased to remit the remainder of the said sentence;

Now, THEREFORE, in exercise of the powers conferred by section 161 (1) of the Constitution of the Federal Republic of Nigeria, 1979 and of all other powers enabling me in that behalf, I, Shehu Usman Aliyu Shagari, President of the Federal Republic of Nigeria, Commander-in-Chief of the Armed Forces of the Federation do hereby remit the unexpired portion of the sentence imposed on the aforesaid Shedrack Uzorie Ugorii.

This will be accomplished through Research, Equipment Design, Testing of Agricultural Equipment and Training of Mechanisation Personnel. The research programe will concentrate initially on land clearing, weeding, harvesting, crop processing, irrigation and drainage, the use of small scale equipment, hand tools and animal drawn equipment. Other problem areas that will receive attention include planting, livestock equipment and rural electrification.

The equipment design programme will initially concentrate on medium and large size power driven equipment for land clearing and other machines and tools suitable for small scale farmers. The Centre should be able to carry its equipment projects from Research and Development through Design, Manufacture and Testing.

4. Duties.—The Project Manager will be responsible for directing the Centre to achieve its objectives. He will be responsible to the Director, Federal Department of Agriculture until the Centre becomes autonomous.

- 5. Conditions of Service.—Conditions of service are the same as in the Federal Civil Service.
- 6. Method of Application.—Applications from candidates not in Government Service should be completed on official Forms obtainable from the Secretary, Federal Civil Service Commission, Federal Secretariat, Ikoyi, Lagos. Applicationsfrom candidates in Government Service should be submitted through the Heads of Departments and be accompanied by copies of confidential Reports for the past three years.
