WHEREAS GODDEY ADEBOSU, having been duly convicted under the Indian Hemp Act, 1966, was sentenced to 10 years imprisonment ;

AND WHEREAS after consultation with the Council of State, I am pleased to remit the remainder of the said sentence ;

NOW, THEREFORE, in exercise of the powers conferred by section 161 (1) of the Constitution of the Federal Republic of Nigeria, 1979, and of all other powers enabling me in that behalf, I, SHEHU USMAN ALIYU SHAGARI, President of the Federal Republic of Nigeria, Commander-in-Chief of the Armed Forces of the Federation, do hereby remit the unexpired portion of the sentence imposed on the aforesaid GODDEY ADEBOSU.
