THE CONSTITUTION OF THE FEDERAL REPUBLIC OF NIGERIA 1979

By the President of the Federal Republic of Nigeria



SHEHU USMAN ALIYU SHAGARI,
President of the Federal Republic of Nigeria,
Commander-in-Chief of the Armed Forces of the Federation

Whereas by section 228 (2) of the Constitution of the Federal Republic of Nigeria 1979 it is provided that the Federal High Court shall consist of a Chief Judge of the Federal High Court and such number of Judges of the Federal High Court as may be prescribed by law:

AND WHEREAS by section 229 (1) of the Constitution of the Federal Republic of Nigeria 1979 it is provided that the appointment of a person to the office of a Judge of the Federal High Court shall be made by the President on the recommendation of the Federal Judicial Service Commission:

Now, Therefore, I, Shehu Usman Aliyu Shagari, President of the Federal Republic of Nigeria, Commander-in-Chief of the Armed Forces of the Federation, acting on the recommendation of the Federal Judicial Service Commission, do hereby appoint Vincent Okosun Eighedion as a Judge of the Federal High Court with effect from the 5th day of April, 1982.

GIVEN under my hand and the Public Seal of the Federal Republic of Nigeria at Lagos, this 31st day of March, One thousand nine hundred and eighty-two.

THE MAGISTRATES' COURTS LAW (CAP. 74)

THE MAGISTERIAL DISTRICT DIRECTIONS, 1982

DATE OF COMMENCEMENT, 1ST JANUARY, 1982

In exercise of the powers conferred by section 3 of the Magistrates' Courts Law, the following Districts are created by the Chief Judge of Oyo State of Nigeria.

- 1. These Directions may be cited as the Magisterial Districts Directions, 1982 and shall come into force on the 1st day of January, 1982.
- 2. Oyo State of Nigeria is hereby divided into Magisterial Districts the names of which are designated in the first column of the Schedule hereto and each such Magisterial District shall comprise the portion of the State assigned opposite its name respectively in the second column of the said Schedule.
- 3. The Magisterial Districts Directions 1969, the Magisterial Districts (Amendment) Directions 1970, the Magisterial Districts (Amendment) Directions 1971 and the Magisterial Districts Directions 1976 are hereby revoked.
