APPOINTMENT OF BOUNDARY ASCERTAINMENT COMMISSION ON BORDER DISPUTES BETWEEN THE CROSS RIVER AND IMO STATES

WHEREAS pursuant to section 4 of the now expired States (Creation and Transitional Provisions) Act 1976 the previous administration appointed a States Boundaries Adjustment Commission for the purpose of resolving boundary disputes arising between some States in the Federation :

AND WHEREAS the said Commission submitted a report which was considered and accepted subject to modifications in certain instances :

AND WHEREAS some boundary disputes still persist as a result of the non-implementation by legal instrument of the accepted recommendations prior to the coming into force of the Constitution of the Federal Republic of Nigeria 1979 :

AND WHEREAS it is necessary and expedient to ascertain the boundaries between the Cross River and Imo States in order *inter alia* to facilitate the operation of section 8 (2) of the Constitution relating to adjustment of boundaries of States and to promote maintenance and securing of public law and order in the areas as concerned :

NOW, THEREFORE, I, SHEHU USMAN ALIYU SHAGARI, President of the Federal Republic of Nigeria and Commander-in-Chief of the Armed Forces of the Federation, hereby constitute a fact-finding Commission designated as the Boundary Ascertainment Commission with the terms of reference hereinafter appearing :

And for this purpose I appoint—

Alhaji Kaloma Ali,

Mr Abidoye Morakinyo Babalola,

Alhaji Sabi Idris,

Mr O. Adebekun.

Mr D. E. Mbata and

Mr U. W. Obot,

to be members of the Commission.

AND I direct that the said Alhaji Kaloma Ali shall be the Chairman of the Commission and I appoint Mr Festus Bola Giwa to be the Secretary to the Commission.

AND I further direct that any two members of the Commission, of whom one shall be the Chairman, shall constitute a quorum and that the Commission shall embark upon its assignment as soon as may be after the date of this Instrument in the affected areas in the Cross River and Imo States and visit such other places as may be found useful for the purpose of carrying out its assignment and upon such dates as the Chairman may determine.

## TERMS OF REFERENCE

2. The Commission shall with all convenient speed ascertain the boundary in any disputed area concerning the Cross River and Imo States :

AND in particular, the Commission shall—

(a) as far as possible, determine the boundary concerned with precision and accuracy and with reference to such natural or artificial landmarks as may be appropriate or otherwise howsoever ;

(b) determine the circumstances leading to the intermittent break down of law and order in the said areas in so far as they relate to inter-State boundary disputes.

- (c) make recommendations as to the avoidance of such incidents in the future; and  
 (d) examine any other matters incidental to the foregoing and make recommendations generally thereon.
3. AND I hereby require the Commission to submit its report to me not later than six months from the date of this Instrument.
