#### PUBLIC NOTICE

#### PRODUCTIVITY, PRICES AND INCOMES BOARD

#### INCOMES POLICY GUIDELINES, 1983

The Government of the Federal Republic of Nigeria has approved the guidelines on wages, salaries, fringe benefits, professional incomes, dividends and prices for the year 1983. Accordingly, pursuant to section 4 (5) of Act No. 30 of 1977, the Productivity, Prices and Incomes Board hereby issues the following notice for the guidance of the general public.



**A. WAGES AND SALARIES****Preamble**

The management of private sector establishments and labour unions should be guided in their negotiation of changes in wages, salaries and fringe benefits by government intention, as enunciated in successive economic plans, of promoting a fairer distribution of incomes and enhancing productivity within a virile economy. Negotiations for adjustments in remunerations and other benefits should ensure the equitable share of income among all factors of production. The need to provide funds for the expansion of industries and promotion of an efficient system of distribution must be taken into account in the allocation of gross profits.

**Private Sector**

(i) The life span of the 1980-82 Incomes Policy Guidelines which allows for maximum adjustments of 15% and 10% in the salaries and incomes of the low and high income groups respectively is extended to 1983. In effect, no general increases in wages and salaries will be permitted in 1983 except in the case where the maximum limits allowed under the 1980-82 guidelines have not been fully implemented.

(ii) Normal annual increments will be permitted. However, negotiations for adjustments in incremental rates are forbidden;

(iii) All establishments employing fifty or more persons are to submit to the Ministry of Employment, Labour and Productivity, productivity schemes drawn up with their employees, and full information on wages, salaries and fringe benefits paid to all categories of their employees, together with the number of employees in each occupational group;

(iv) No revisions of fringe benefits or introduction of new ones will be valid except with the specific approval of the Ministry of Employment, Labour and Productivity. Management and Unions negotiating for upward review of fringe benefits or the introduction of new ones must enclose a copy of their productivity scheme and show evidence of improvement in labour productivity and increased profits for sharing among factors of production;

(v) All bonus payments shall be regarded as ex-gratia payments. Proposals for the payment of bonus to workers shall be submitted to the Minister of Employment, Labour and Productivity for approval. The total expenditure on such ex-gratia payment must not be more than 2% of the preceding year's net profit provided that no employee shall receive an amount higher than one month's basic pay;

**Public Sector**

(vi) Adjustments in salaries in the public sector in 1983 should be based on the implementation of the 1982 Incomes Policy Guidelines and Government decisions on panels or commissions set up to deal with conditions of service of particular groups;

(vii) After 1983, adjustments in pay in the Civil Service should be negotiated on the basis of studies carried out by Pay Research Unit;

(viii) Adjustments in pay in the other parts of the public sector after 1983 should be based on negotiations (using studies completed by the Pay Research Unit as basis) and the recommendations of the Top Salary Advisory Panel;

(ix) Negotiations for fringe benefits in the Civil Service should be based on the studies carried out by the Pay Research Unit, while for the rest of the Public Service, such changes should be subject to the approval of the Minister of Employment, Labour and Productivity as provided in paragraph 74 of the Government White Paper on the Report of the Presidential Commission on Parastatals;

(x) Ex-gratia payments to workers should be cleared with the Supervising Minister, the Minister of Finance and the Director of Budget/Special Adviser to the President on Budget Affairs. The total sum payable and the maximum permissible limit shall be as provided in (v) above.

**General Application to both Sectors**

(xi) Arrears arising from any changes in incomes shall not be back-dated. Where it is necessary to do so for exceptional reasons, the effective date should not go beyond the beginning of the current year.

**B. Professional Incomes Guidelines**

(i) There shall be no changes in the remuneration (i.e. fees, allowances and any other pre-requisites in cash or kind) of non-executive members of Boards in the private sector during the year. However, fees of non-executive directors could be increased by a maximum of 10% provided that the total fees do not exceed ₦3,000.00 a year. Increases above ₦3,000.00 can only be implemented after consultation with the Board;

(ii) Government approved rates for professional services such as those provided by architects, Estate Managers, Locum Medical Doctors, Engineer—Civil, Mechanical and Electrical Quantity Surveyors, etc., shall be adhered to throughout the economy, i.e. in both the public and private sectors;

(iii) The scale rates for fees charged by accounting and auditing firms for 1981 shall be applicable in 1983 provided that the total amount payable does not increase by more than 10%;

(iv) The payment of fees, charges, retainers etc., higher than those specified in (ii)-(iii) above will not be accepted by the Internal and Inland Revenue Departments as expenses for tax purposes.

**C. Dividends**

(i) Dividends up to 60% of current year's after-tax profit may be declared and distributed;

(ii) A withholding tax of 12.5% is payable on all dividends;

(iii) The issue of scrips based on a revaluation of assets is forbidden;

(iv) For effective monitoring, companies are required to submit a copy of their annual reports and accounts to the Secretary, Productivity, Prices and Incomes Board and to the Head, Incomes Analysis Unit, Federal Ministry of National Planning;

(v) For the avoidance of doubt, the guidelines which obtain on the date of a company's annual general meeting shall apply in determining its distributable dividend, provided that the timing of the annual general meeting is in accordance with the provision of section 124 (1) of the Companies Act, 1968.

#### D. PRICE GUIDELINES

(i) A single increase in price of not more than 5% during the year can be effected after prior consultation provided that the Board is notified 40 days in advance. No subsequent increase even if below 5% can thereafter be implemented except with the approval of the Board;

(ii) Prior notification of not less than 10 weeks must be given for price increases above 5%;

(iii) Companies applying for price increases should enclose a copy of their annual report and accounts for the preceding three years. Cost, information and other data in support of the application should also be enclosed;

(iv) Importers of all heavy industrial machinery for resale should not apply a mark-up of more than 25% of the CIF;

(v) Importers/dealers in motor spare-parts should not apply a factor of more than 2.0 to CIF. Other officially approved local costs may be added to arrive at the selling price;

(vi) Increases in rates charged for advertisements in the media as well as fees and commissions charged by advertisement agencies should be made in the manner stipulated in paragraphs (i) and (ii) above;

(vii) Increase in the rentals paid for the hiring and maintenance of machines and equipments should be made in the manner stipulated in paragraphs (i) and (ii) above;

(viii) Where there is a net reduction in allowable cost per unit of output, prices should be reduced by an amount equal to any percentage reduction resulting therefrom. The Board may therefore, call on any firm to reduce the prices if there is evidence of reduction in allowable costs;

(ix) It is forbidden for companies to apply for price increases on the basis of anticipated increases in costs;

(x) Changes in prices of items determined through the application of government approved formula will not be governed by the price guidelines but by specific application to the Ministry of Commerce;

(xi) All advertisements for the sale of goods and services in any news-media must carry actual prices of the particular goods or services advertised. The prices of all traded goods and services must be conspicuously exhibited to guide consumers.

#### E. CERTIFICATION

Auditors' reports on companies and other institutions must contain statements as to whether or not the provisions of the Incomes Policy Guidelines, as specified above, have been adhered to in every respect.

#### F. PENALTY

Failure to comply with the provisions of these guidelines shall be punishable under section 5 (2) of Act No. 30 of 1977.
