(i) "Termination of appointment of a key union member Mr Joseph U. Temienor without just cause.

(ii) Confiscation of Mr Temienor's salary for September, 1980 without valid reason.

(iii) Refusal by Management to accept mediation as prescribed by Section 3 (2) of the Trade Dispute Act No. 7 of 1976.

(iv) Management's use of subtle and unfair means to induce Union members to resign their membership of the Union as well as prevent new employees from joining the Union—for example, by offering them better terms and conditions of service than are contained in the Company's Collective Agreement with Union.

(v) Incessant intimidation of, and naked discrimination against the accredited representatives of the Union within the Establishment with a view to frustrating them.

(vi) Wrongful "Suspension without pay" of the Union's Domestic Committee Secretary from 6th October, 1982 to 17th November, 1982 while at the same time ordering him to carry out certain official duties during the same period of suspension.

(vii) wrongful dismissal of Kenneth Mbaeri.

(viii) Unjustly instructing the Company's medical Doctors never to grant sick leaves to staff no matter the seriousness of their illness.

(ix) Unjustly denying Union members annual increment while granting even merit increments to non-union members."
