#### ARRANGEMENT OF ARTICLES

#### ARTICLE

- 1. The College of Medicine.
- 2. The Provost.
- 3. The Deputy Provost.
- 4. Faculties.
- 5. Faculty Board of Studies.
- 6. Deans of Faculties.
- 7. Board of the College of Medicine.
- 8. The Secretary.
- 9. Financial Controller.

- 13. Citation and commencement.

#### COMMENCEMENT: 3RD DECEMBER 1982

In exercise of the powers conferred by sections 3 (1) (a), 3 (3) and 9 (1) (a) of the University of Nigeria Act 1978, and of all other powers enabling it in that behalf, the University of Nigeria, with the approval of the National Universities Commission and the further approval of the President of the Federal Republic of Nigeria and Commander-in-Chief of the Armed Forces of the Federation, hereby makes the following

#### THE COLLEGE OF MEDICINE

- 1.—(1) There is hereby established as an integral part of the University, a college to be known as the College of Medicine of the University of Nigeria (hereinafter in this Statute referred to as "the College") in its corporate name.
  - (2) The College shall—
  - (a) as respects its general governance and control, be responsible to the Council; and
  - (b) as respects academic matters be responsible to the Senate.
- (3) Subject to the overall control of the Council, the College shall have power to manage its own financial

#### PROVOST

- 2.—(1) There shall be a Provost of the College who shall be the chief executive officer of the College and shall be responsible to the Vice-Chancellor for the day-to-day running of the College.
- (2) The Provost shall be elected by the Academic Staff Assembly of the College from amongst the Professors in the College at a duly constituted meeting of the Assembly at which the election of the Provost is on the agenda.
- (3) The Provost shall hold office for two years from 1st of August of the year in which he is elected and shall be eligible for re-election for another term of two years.
- (4) A person who has held office as Provost for a continuous period of four years shall not be eligible for re-election as Provost until four years have elapsed since he last held such office.
- (5) No person shall while holding the post of Provost also be the Dean of a Faculty or Head of any
- (6) A meeting of the Academic Staff Assembly for the election of a Provost shall be held in the month of May or June immediately preceding the expiration of the term of office of an incumbent and the Vice-Chancellor or his nominee shall preside over such meeting.
- (7) Notwithstanding the provisions of paragraph (6) of this section, elections for the appointment of the first Provost shall be held in 1982 so soon after the coming into effect of this Statute as the Academic Staff Assembly shall determine; and the Provost so elected shall vacate office in accordance with the provisions of paragraph (3) of this section.

#### DEPUTY PROVOST

3.—(1) There shall be a Deputy Provost of the College who shall assist the Provost and act in his place if the office of the Provost is vacant or the Provost is for any reason (including absence from the precincts of the College) unable to perform his functions as Provost.

(2) The Deputy Provost shall be elected from amongst the Professors in the College by the Academic

Staff Assembly of the College.

(3) The Deputy Provost shall hold office for two years beginning with the 1st of August of the year in which he is elected and shall be eligible for re-election for another term of two years.

(4) A person who has held office as Deputy Provost for a continuous period of four years shall not be

eligible for re-election as Deputy Provost until four years have elapsed since he last held such office.

(5) No person shall while holding the office of Deputy Provost of the College also be the holder of the office of the Dean of a Faculty or Head of any Department in the College.

(6) A meeting for the election of the Deputy Provost shall be held in the month of May or

June immediately preceding the expiration of the term of office of the current Deputy Provost and the Vice-

Chancellor or his nominee shall preside over such meeting.

(7) Notwithstanding the provisions of paragraph (6) of this section, elections for the appointment of the first Deputy Provost shall be held in 1982 so soon after the coming into effect of this Statute as the Academic Staff Assembly shall determine; and the Deputy Provost so elected shall vacate office in accordance with the provisions of paragraph (3) of this section.

#### FACULTIES

- 4.—(1) The College shall consist of Faculties and Institutes which shall be made up of Departments and such other academic units as shall be established in accordance with the procedures prescribed in that behalf by the University.
  - (2) The following Faculties shall constitute the foundation faculties of the College :-

(a) the Faculty of Medical Sciences and Dentistry; and

(b) the Faculty of Health Science and Technology.

#### FACULTY BOARD OF STUDIES

5.—(1) There shall be established for each Faculty of the College, a Board of Studies.

(2) The Board of Studies shall consist of-

(a) the Vice-Chancellor and the Deputy Vice-Chancellor(s):

(b) the Provost and the Deputy Provost:

(c) the Deans of the Faculties in the College;

(d) the Medical Librarian;

(e) all the academic staff of the College; and

- (f) such other persons, whether or not members of the University, as the Board of Studies may, with the general or special approval of Senate, determine.
  - (3) The Board of Studies shall-
- (a) advise and report to the Academic Board on all matters relating to the organisation, teaching and research into the subjects taught in the College including the development and review of curricula and the conduct of examinations:
- (b) consider the progress and conduct of students in the teaching units and report thereon to the Academic

(c) recommend to the Academic Board persons for appointment as examiners; and

- (d) deal with such other academic matters as may be referred to it by the Academic Board.
- (4) The quorum of the Board of Studies shall be eight or one-quarter of the entire members thereof (whichever is the greater).
- (5) The Dean shall be the Chairman at all meetings of the Faculty Board when he is present; and when he is not present, such other member of the Board as may be acting for the Dean for the time being, shall preside at that meeting.

#### DEANS OF FACULTIES/

- 6.—(1) The dean of a faculty shall be a professor elected by the Faculty Board and each dean shall hold office for a term of two consecutive academic years after which he shall not be eligible for re-election until four years have elapsed.
- (2) If there is no professor in a faculty, the office of the dean of the faculty shall be held in rotation by academic members of the faculty holding the ranks of reader or senior lecturer on the basis of seniority as determined by the Senate.
- (3) The dean of a faculty shall exercise general superintendence over the academic and administrative affairs of the faculty. It shall be the function of the dean to present to convocation for the conferment of degrees and other qualifications persons who have qualified for such degrees or other qualifications of the University at examinations held in the branches of learning for which responsibility is allocated to that faculty.

#### BOARD OF THE COLLEGE OF MEDICINE

7.-(1). There shall be a Board of the College of Medicine (hereinafter in this Statute referred to as "the Board of the College") which shall be subject to the overall control of the Council.

(2) The Board of the College shall-

(a) control the property and expenditure of the college;

- (b) submit to the Council, through the Vice-Chancellor, any financial proposals relating to the College;
- (c) employ on such terms and conditions within the frame-work of the conditions of service governing the appointment of non-academic staff in the University, such non-academic staff as may appear to the College Board to be necessary;
  - (d) to appoint all academic staff of the College of up to and including the level of senior lecturers; and (e) perform such other functions of the Council as the Council may from time to time delegate to it.

(3) The Board of the College shall consist of-

(a) the Pro-Chancellor and Chairman of the Council, as Chairman of the Board;

(b) the Vice-Chancellor :

(c) the Chairman of the University of Nigeria Teaching Hospital Management Board;

(d) the Provost and the Deputy Provost of the College;

(e) deans of faculties of the College :

(f) one person, who is not a member of the academic staff of the University nominated by the Council;

(g) two members of the Senate who are not members of the College, nominated by the Senate;

- (h) two persons who are members of the academic staff of the College, nominated by the Academic Board;
  - (i) one member appointed by the University of Nigeria Teaching Hospital Management Board;

(j) the Permanent Secretary of the Federal Ministry charged with responsibility for matters relating to health, or his representative; and

(k) the Permanent Secretary of the Federal Ministry charged with responsibility for matters relating to University education or his representative.

(4) The quorum of the Board of the College shall be six.

- (5) Members of the Board of the College shall hold office for a period not exceeding four years.
- (6) A member of the Board of the College appointed under sub-paragraphs (f) to (i) of paragraph (3) above shall hold office for such period as may be determined by the body by which he is nominated.

#### SECRETARY

8.—(1) There shall be a Secretary to the College who shall, under the general control of the registrar of the University, carry out such duties of an administrative nature as may from time to time be assigned to him by the Board of the College and, subject thereto, by the Provost.

The Secretary to the College who shall be the status of a senior deputy registrar, shall be appointed on behalf of the Council by the Board of the College.

(3) The person holding the office of the Secretary to the College shall by virtue of that office be the Secretary to the Board of the College, the Academic Board and the Academic Staff Assembly.

#### FINANCIAL CONTROLLER

- -(1) There shall be a Financial Controller of the College who shall, under the general control of the University Bursar, be responsible to the Provost for the day-to-day administration of the financial affairs of the
- (2) The Financial Controller of the College who shall be of the status of a chief accountant, shall be appointed on behalf of the Council by the Board of the College.

#### ACADEMIC BOARD

- 10.-(1) There shall be an Academic Board of the College which shall have control of the academic affairs of the College and shall be responsible and subject to the control of the Senate in all academic matters. It shall also exercise such of the powers of the Senate as the Senate may from time to time delegate to it.
  - (2) The Academic Board of the College shall consist of-

(a) the Vice-Chancellor or his representative;

(b) the Deputy Vice-Chancellor;

(c) the Provost and the Deputy Provost of the College; (d) the deans of the faculties within the College;

(e) the professors in the College; (f) the medical librarian of the College;

(g) the persons for the time being holding such appointments on the staff of the College as may be specified by the Provost of the College with the approval of the Vice-Chancellor; and (h) not more than two other members of the academic staff of each faculty within the College elected from

amongst the members in accordance with paragraph (5) of this Article.

- (3) The quorum of the Academic Board shall be ten or one-quarter (whichever is the greater) of the members for the time being of the Board.
- (4) The Provost of the College shall be the chairman of all meetings of the Academic Board of the College when he is present and when he is not present, the Deputy Provost, or where they are both absent, any person for the meantime performing the functions of the Provost shall preside at that particular meeting of the Academic Board.
- (5) The Academic Board shall make Regulations prescribing the procedure for the election of members of the Academic Board under sub-paragraph (g) above, who shall hold office for a period of two years beginning with the 1st of August in the year of his election and shall at the expiration of his term be eligible for re-election, so however, that no person shall be eligible for re-election at the end of his current period of office if he shall office, as an elected member of Board, for a continuous period of six years or would have so held office if he had not earlier resigned it.

#### ACADEMIC STAFF ASSEMBLY

- 11.—(1) There shall be an Academic Staff Assembly of the College which shall consist of all full-time academic staff of the College.
  - (2) The quorum of the Assembly shall be twenty.
  - (3) The functions of the Academic Staff Assembly shall be-
  - (a) to elect representatives to various bodies on which the Academic Staff Assembly of the College is specifically required to be represented;
    - (b) to elect a Provost for the College from among the full-time professors of the College;
    - (c) to elect a Deputy Provost for the College from among the full-time professors of the College; and
    - (d) to perform such other functions as the Academic Board may from time to time, refer to it.
- (4) The Provost shall be the chairman at all meetings of the Academic Staff Assembly when he is present, and when he is not present, the Deputy Provost or one of the Deans of Faculty as may be mandated by the Provost shall be the chairman at the meeting: Provided that when the Assembly meets to elect a Provost or Deputy Provost, the Vice-Chancellor or his nominee shall preside as chairman.

#### INTERPRETATION

Any word or expression used in this Statute shall have the same meaning as defined in the University
of Nigeria Act 1978.

#### CITATION AND COMMENCEMENT

- 13.--(1) This Statute may be cited as the University of Nigeria Statute No. 2.
- (2) This Statute shall come into force on 3rd December, 1982.
