Background and justification.—The development of skilled manpower in Botswana is one of the most important areas of concern to the Government. The Presidential Commission on Economic Opportunities reaffirms that the Government must now do more to meet the economy's requirement for skilled manpower. Botswana cannot afford to ignore the inherent skills and aptitudes of its people including those who lack or have little formal education.

The Apprenticeship and Industrial Training Act of 1983 intends to provide opportunities for those who are employed in industry and have developed basic skills for upgrading through the trade testing and certification system during the course of their employment in Botswana. This will be achieved through the Trade Testing Unit of Industrial Training Division under the Labour Department.

The first recorded trade tests were carried out in Botswana in 1962 starting with drivers and gradually incorporating other occupations over the years. This Department received an 18 months' ILO/UNDP assistance under the project BDT/78/011 to develop and implement systematic trade testing scheme. Unfortunately, the project came to an end in June 1981, partly because of lack of funds and partly due to other difficulties but now the project is coming up on its footings in Botswana. The Apprenticeship and Industrial Training Act has passed Botswana Parliament in December 1983. The Act provides for trade testing in Part V.

A feasibility study on strengthening the industrial training and trade testing was caried out by two German consultants and the report has been submitted to the Government of Botswana. It has been recommended to use the services of an ILO.

Adviser for the purpose of updating and strengthening the trade testing system in Botswana.

As the Act is expected to be operational by September 1985, so there is a vital role to be played by ILO consultancy to update and strengthen the whole trade testing system. The Act further provides training opportunities for those who are employed in industry and developed job skills in their trade during the course of employment. Through systematic trade testing and certification, the specific training requirements of these employee will be ascertained and implemented by the Industrial Training Unit.

In addition, it is expected to develop training standards for apprentices from the trade testing standards in selected trades.

liaise with the Chief-Trade Testing Officer on all matters of Trade Testing Unit and with the relevant trade advisory committees;

advice on general workflow and procedures of Trade Testing Unit, including filing, record-keeping and compiling of data and information;

advice on the ongoing exercise for the purpose of revising existing standards in various trades; advise and assist to develop the new standards in the following trades;

- (1) textile trades;
- (2) printing trades;
- (3) hotel and catering industry trades;
- (4) office equipment maintenance trades;
- (5) banking trades;
- (6) meat technology trades;
- (7) earth-moving equipment and machinery trades;

advise and draft trade testing regulations in the light of the provisions of the Act;

advise on developing standard question paper formats for theory as well as practical tests and grading;

advise on suitable upgrading courses for trade testing officers and conducting at least short workshops for them; advise on developing the training standarsd for apprentices for the existing testing standards in the following trades:

(1) auto-mechanic;
