## SECURITIES AND EXCHANGE COMMISSION

NOTICE TO ALL ENTERPRISES WITH  
ALIEN INTEREST AND PUBLIC  
COMPANIES

According to Section 7 (1) of the Securities and Exchange Commission Act, 1979 no public company and no enterprise in which aliens participate whether constituted as a public or private limited or unlimited liability company or partnership, shall issue or sell any of its securities without having obtained the prior approval of the Commission with respect to :—

(a) the price at which the securities are to be sold ;

(b) the timing and amount of sale ;

(c) in the case of a company whose securities have been granted a quotation on any Stock Exchange, the timing and amount of any subsequent issue or supplementary offers for sale and the price at which the securities shall be sold ;

(d) whether the initial or subsequent issue or sale of the securities issued by the enterprises shall be restricted or made public and when such an enterprise shall seek quotation on the Stock Exchange.

It has come to the notice of the Commission that some enterprises to which the aforementioned Section applies have been issuing or transferring shares in contravention of the law.

Notice is hereby given to all enterprises with alien interest which had issued or sold, or transferred securities in contravention of the Act to apply to the Commission for the regularisation of such issues, sales or transfers on or before 31st July, 1985. For the avoidance of doubt, the said Section 7 (1) also affects initial issues of shares by new companies or enterprises with alien interest.

Any violation of this Section of the Act which is not regularised before 31st July, 1985 and any subsequent contravention of this Section of the Act thereafter will attract penalties as provided for by Section 7 (3) (a) and (b) as follows:—

"7 (3) If a body to which this Section relates acts in contravention of this Section, then, subject to Section 10 below :

(a) the body shall be guilty of an offence and liable on conviction to a fine of ₦100,000 and in addition to a penalty of ₦1,000 per day for the period during which the offence subsists ;

(b) every Director, Manager, Secretary or other similar officer, servant or agent of the body (or any person purporting to act in any such capacity) who knowingly and wilfully authorised the contravention shall also be guilty of an offence and liable on conviction to a fine of ₦10,000 or to imprisonment for not less than three years or both".

Section 10 provides as follows :—

"Without prejudice to Section 104 of the Constitution of the Federation (which relates to the power of the Attorney-General of the Federation to institute, continue or discontinue criminal proceedings against any person in any court of law) the Commission may compound any offence

punishable under this Act by accepting such sums of money as it thinks fit not exceeding the amount of the maximum fine to which that person would have been liable if he had been convicted of that offence".
