Note.—Any person who intends to appear on the hearing of the said petition must serve on or send by post to the above-named chambers notice in writing of his intention so to do. The notice must state the name and address of the person, or if a firm the name and address of the firm and must be signed by the person or firm or his or their solicitor (if any) and must be served or if posted must be sent by post in sufficient time to reach the above-named chambers not later than 48 working hours before the date the petition is for mention in Court.
