#### Oil Pipelines Act (Cap 145) 1956

#### APPLICATION FOR AN OIL PIPELINE LICENCE

- 1. Notice is hereby given in accordance with Section 8 of the Oil Pipelines Act (Cap. 145) 1956 as amended by the Oil Pipelines Act 1965, that Mobil Producing Nigeria whose registered address is at Bookshop House 50/52, Broad Street, Lagos has applied to the Honourable Minister of Petroleum Resources for the grant of a licence to enter upon and take possession of, for laying an 18 inch O.D. pipeline 0.5 inch thick and 7.0 km long from Edop "A" Well Platform to the Inim Production Platform in OML 67 located offshore, Cross River State of Nigeria.
- 2. The pipeline route shown in Drawing No. 00106 is described as follows: starting at a point at the Edop "A" Well Platform location whose Nigerian Co-ordinates are N612,260 metres; E16,560 metres and whose Geographic Co-ordinates are Lat. 04 degree 08' 58.6" N Long. 07 degree 58'29.4" E a distance of approximately 7,010m. (23,000') and terminating at the Inim Production Platform whose Nigerian Co-ordinates are N23,725 metres E614,622 metres and whose Geographic Co-ordinates are Lat. 04 degree 12'51" N; Long. 07 degree 59'45" E.

All co-ordinates, bearings and distances are approximate.

- 3. A copy of the plan of the pipeline route identifying the area affected can be inspected between 07.30 hours and 15.30 hours, Mondays-Fridays at the offices in Lagos and Port Harcourt of the Petroleum Inspectorate and at the Ministry of Housing and Environment (Lands Division), Calabar.
- 4. Any person who considers that his interest in the area will be injuriously affected by the grant of this licence should lodge notice of the objection orally or in writing and not less than seven days before the hearing date stated in paragraph 6 below, with the Lands Division of the Ministry of Housing and Environment, Calabar stating his interest and the grounds of objection.
- 5. Any public officer who receives a verbal objection in the course of his duties should record the name and address of the complainant as well as his interest and grounds of objection, and forward such details to the Lands Division of the Ministry of Housing and Environment, Calabar and/or the nearest office of the Petroleum Inspectorate of the Nigerian National Petroleum Corporation.
