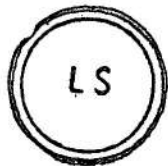

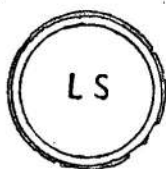

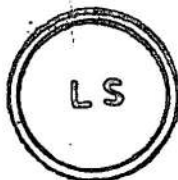

Rules of Court Advisory Committee
