ADVERTISEMENT OF PETITION

The humble petition of Lagos State Development and Property Corporation sheweth as follows:—

(1) The Build-Spec Construction Company Limited (hereinafter called the Company) was on the 5th day of August, 1981 incorporated under the Companies Act as No. RC 40803.

(2) The registered office of the Company is at the LSDPC—Low Cost Housing Scheme, Amuwo-Odofin, Lagos, Badagry Expressway (presently being occupied also by the New Town Development Authority).

(3) The nominal capital of the Company is ₦1,000,000 divided into 1,000,000 ordinary shares of ₦1.00 each. The amount of the Capital paid up in cash was ₦800,000 and ₦160,183 fully paid for other consideration other than cash thus bringing the total credited as paid up as ₦960,183.00.

(4) The share holding of the owners as originally planned were as follows:—

(5) The petitioner released its own contribution of ₦550,000 with despatch and ₦50,000 was paid by Chief Afolabi James also.

(6) Two members of the Board of the petitioner were the Chairman and Director of the Company while other Board members of the Company included Mr F. Zanon de Fez (Managing) Mr Lopez Tapia and Chief A. O. James.

(7) The objects for which the Company was established are as follows:—

To carry on the business of Civil Engineers builders, masonry and general construction contractors and hauliers and among other things to construct, execute, carry out, equip, improve work and advertise railways, roadways, trainways, docks harbours, wharves houses, buildings and erection of every kind and to carry on any other business in connection with the above mentioned businesses that are customarily or usually carried on in connection therewith or naturally incidental thereto and all other objects set forth in the memorandum of Association thereof.

(8) Prior to the establishment of the Company the Government of Lagos State embarked on the construction of Low-Cost Housing Schemes in fulfillment of its promise to the people to house its citizens.

(9) In pursuit of this Housing Programme, the Lagos State Government directed the petitioner being the Government Parastatal Organisation for building and housing matters to enter into two contracts with Pureway Corporation of Nigeria and Cazan Construction Company Limited for the construction of 14,000 Low-Cost Houses at a total cost of ₦94,963,553.28 at some sites in Lagos.

(10) Shortly after the award of these contracts the Petitioner opened irrevocable letters of credit in favour of the two Companies for the importation of machinery and equipments purportedly for the execution of the contracts at a total cost of ₦9,411,790.41 through a provision for 15% of the contract price to the two companies.

(11) Very soon after the transaction was concluded the Lagos State Government discovered that some actions of its functionaries through the petitioner had undertaken the importation of the machinery and equipments by the issuance of the letters of credit without authority of the Government which was funding the contracts, and to salvage the situation and safeguard its resources, it decided that the equipments should be taken over by the Petitioner as soon as they arrived at the port and the Government would then form a Company with these two contracting Companies for the execution of the contracts.

(12) The petitioner's shareholding was increased to 75% (₦750,000) when a Director Lopez Tapia was unable to pay up his 20% Equity participation and further increased to 79% (or ₦790,000) when Mr Zanon was not able to settle the balance of his participation which in effect limited him to 16% while the balance was added to the interest of the petitioner.

(13) With the above arrangement, the petitioner funded and increased its equity participation to 79%.

(14) While the Company commenced work, it obtained and secured an overdraft facility to the tune of ₦2 Million from United Bank for Africa Limited (U.B.A. Ltd.). This Loan was guaranteed by the Petitioner in May 1983 while as a collateral, a debenture by way of a floating charge was secured on the Company's assets consisting mainly of machinery and equipments taken over from the petitioner as explained in paragraph 11 hitherto.

(15) In accordance with the working programme the Company imported composite beams for the floor slabs from Spain at a total cost of ₦1,127,696. The unused balance of the beams at the time of cessation of operations was assessed as ₦798,538.23 and altogether with other building materials left by the Company came to a total of ₦888,312.98.

(16) The Company ran into various problems ranging from management to manpower and technical know-how and it ceased to operate from 31st May, 1984.

(17) (Prior to this date) The Company had a published audited account covering 14 months period ending on the 30th September, 1982 and an unpublished account for the period between 1st October, 1982–31st December, 1983.

(18) During these periods, the Company recorded losses of ₦1,580,856 and ₦4,264,702 due to the high rate of maintenance and depreciation of the machinery and equipments.

(19) At this time also, the Company had received certificates for works done at Iba Scheme for which the sum of ₦4,551,919.96 was due while earlier claims for ₦1,526,577.09 were already awaiting settlement.

(20) When the New Military Administration came to power in 1984, Fadina's Panel was set up to look into the establishment and other matters of the Government owned Companies and Parastatals and part of its recommendations centred on measures to salvage the assets of Companies which had ceased to function and cut down on losses.

(21) (a) Among steps taken in this direction were the movement of all the Company's equipments and machinery to a safe site at Amuwo-Odofin Plant Yard from Iba.

(b) The Petitioner took over 17 light vehicles including Cars and Kombi Buses for its own operations and these according to their book value are put at ₦91,620.68.

(c) Taking over of all the building materials left at Iba site valued at ₦888,312.80.

(d) Taking over of the Company's office at Amuwo-Odofin including furniture and office equipments.

(e) Taking over of the fully furnished flats at Block 333 with boys quarters at Amuwo-Odofin.

(f) Taking over of the Construction site at Iba and the completion of the houses then in progress.

(22) The liabilities of the company are as follows :
