

FINANCE (MISCELLANEOUS TAXATION PROVISIONS) DECREE NO. 12 OF 1987

INCOME TAX MANAGEMENT ACT 1961 SECTION 21EE

(1) Pursuant to the provisions of section 21EE of the Income Tax Management Act 1961 as amended by section 4 of the Finance (Miscellaneous Taxation Provisions) Decree No. 12 of 1987, any person from whom any payments are due in respect of activities listed hereunder is hereby required to deduct tax therefrom at the rate specified—

*Payments in respect of :**Rates at which tax is to be deducted :*

All aspects of building, construction and related activities	2½%
All types of contract activities or agency arrangement other than outright sale and purchase of goods and property in the ordinary course of business	2½%
Consultancy and professional Services	5%
Management Services	5%
Technical Services	5%
Commissions	5%

(2) Persons required to deduct tax from such payments include companies, Government Ministries and Departments, Local Government, Parastatals, Statutory bodies, Institutions and other organisations, establishments and enterprises approved for the operation of Pay As You Earn Scheme.

(3) The deduction are not and should not be regarded as additional cost of contracts or services rendered and should therefore not be built into costs. They are deductions in lieu of tax.

(4) A person who has deducted tax from such payments shall issue a receipt for the amount of tax deducted and a statement showing details prescribed in paragraph 6 below.

(5) Such person shall forward the tax deducted and the accompanying statement to the relevant Tax Authority of the State in which the individual i.e. the recipient of the payment, is resident.

(6) The person making the remittance of the deduction made shall state the following information in writing :—

- (a) Name and address of the person which suffered the tax deduction ;
- (b) Nature of activities or services in respect of which payments were made ;
- (c) Gross amount paid or payable ;
- (d) Amount of tax deducted ;
- (e) Amount of tax remitted ;
- (f) Date of remittance.

(7) For the purpose of final assessment, the individual beneficiary of such income that had suffered deduction of tax at source shall present the original receipt issued in respect of the tax deducted at source to the relevant Tax Authority for scrutiny whenever a claim for tax credit is made.

(8) For the avoidance of doubt, it is hereby notified that the regulations published in the Government Gazette No. 34, Vol. 72 of 27th June, 1985 as they affect companies remain unchanged. In this connection, tax deducted from payments made to companies shall continue to be remitted to any of the offices of the Federal Inland Revenue Department.

(9) Deductions at the rates specified above and by virtue of this Notice from payments made to a person shall be remitted only to the relevant tax authority of the State in which the person i.e. the recipient of the payment, is deemed to be resident.

(10) A body corporate or unincorporate and any association or institution obliged to deduct tax at source under the Decree and by virtue of this Notice but who fails to do so or having deducted tax fails to pay over such tax to the relevant tax authority within thirty days from the date the tax was deducted or the duty to deduct tax arose shall be liable on conviction to a fine of ₦5,000 in addition to the amount of tax deducted together with interest at the prevailing commercial rate. Such payments may also be disallowed as deductions in ascertaining the income or loss for tax purposes of the body corporate or unincorporate, association or institution.
