WHEREAS CHIEF (DR) JOHN ADEWUNMI SODIPO was tried and convicted under section 161 of the Exchange, Control (Anti-Sabotage) Act 1977;

AND WHEREAS, CHIEF (DR) JOHN ADEWUNMI Sodipo was convicted on three counts and sentenced to 10 years imprisonment on each count and fined the sum of N296,456;

AND WHEREAS CHIEF (DR) JOHN ADEWUNMI SODIPD had served his term of imprisonment until 1980 when he was granted remission and has paid the fine of 18296,456 and consequently appealed by way of petition to the President, Commander-in-Chief of the Armed Forces for clemency and pardon to enable him enjoy all his civic rights;

Now, THEREFORE, I, GENERAL IBRAHIM BADAMASI BABANGIDA, President, Commander-in-Chief of the Armed Forces, in exercise of the powers conferred upon me by section 161 (1) of the Constitution of the Federal Republic of Nigeria 1979, as modified by the Constitution (Suspension and Modification) (Amendment) Decree 1985, do hereby grant a free pardon to the said CHIEF (DR) JOHN ADEWUNMI SODIPO.
