NOTES ON THE ACCOUNTS FOR THE YEAR ENDED 31ST DECEMBER, 1988

1. Accounting Policies.—

(a) *General*.—In preparing its accounts, the Bank applies a combination of accounting principles commonly used in the private and public sectors which best reflect its financial position and the results of its operations.

(b) *Fixed Assets*.—Expenditure on land and building is written off each year against provision for capital projects as in Note 1 (h) (ii), while that on furniture and equipment is treated as part of operating expenses.

(c) *Foreign Exchange*.—Transactions in foreign currencies are converted at the prevailing rates for the particular transactions.

External assets and liabilities at the balance sheet date are translated into Naira at the rates ruling at the balance sheet date.

Profits and losses arising from currency conversion other than those arising from Federal Government obligations are transferred to Foreign Exchange Revaluation Suspense Account. The balance on the revaluation suspense account, at the balance sheet date, is reviewed and adjusted as deemed necessary by way of transfer to or from Miscellaneous Provisions Accounts.

(d) *Gold*.—The Bank's gold is stated at cost.

(e) *Federal Government Securities*.—Federal Government Securities are stated at cost.

(f) *Investment*.—Investments held in Government Parastatals are stated at cost.

(g) *General Reserve*.—An annual transfer is made to the general reserve account of an amount representing approximately 1/16 or 6.25% of the operating surplus of the Bank for the year.

(h) *Miscellaneous Provisions*.—Charges made by way of provisions to the Income and Expenditure Account are as follows :—

(i) *Internal Currency Insurance*.—This provision is built up to cover possible losses that could arise from the currency stock held within the Bank and in transit.

(ii) *Capital Projects*.—A transfer is made annually to capital projects provisions account of an amount equal to the estimated cost of all projects approved by the Board during the year. Capital cost incurred during the year is charged to this account.

(iii) *Agricultural Credit Fund*.—This is the amount required to meet the Bank's commitment in respect of Agricultural Credit Guarantee Scheme Fund.

(iv) *External Fluctuation*.—This represents amount set aside to meet possible losses that may arise from foreign exchange fluctuations.

(v) *Contingency*.—This provision is made to cover unexpected fluctuations in the value of investments and other assets not specifically covered by any of the other provisions in (i) to (iv) above.

2. *Gold*.—The market value of Gold held at 31st December, 1988, was ₦1,506,227,649 (1987—₦1,384,053,765).

10. *Trade Debts Promissory Notes.*—Under an agreement reached with Note holders on 14th January 1988, the Central Bank, on behalf of the Federal Government of Nigeria, issued new US \$ Promissory Notes to refinance arrears of trade debts including principal and unpaid interests up to 5th January, 1988 on the existing Promissory Notes.

The new notes have a moratorium period of two years during which eight equal quarterly instalments at the rate of 1.25% of the face value of the notes are to be paid to Noteholders. Thereafter, a fixed payment of 2% of the face value of the notes will be made on 5th April, 1990 and each of the 79 succeeding quarterly days up to and including 5th January, 2010 in full discharge of liability under the notes.

A noteholder may redeem the Notes in whole or in part in Naira in accordance with the Debt Conversion Programme being administered by the Central Bank of Nigeria.

Promissory Notes issued and outstanding at the balance sheet date have been translated to Naira at the exchange rate ruling at that date and the resulting exchange difference which is recoverable from the Federal Government of Nigeria has been taken to Exchange Difference on Promissory Notes Account. (See Note 8).
