

- "1. The unilateral declaration of redundancy of employees by AIICO management on 4th March, 1989 without consultation with the Union is a breach of the Collective Agreement and the practice between the parties, hence unlawful and should be declared null and void and of no effect.
- 2. That the status quo ante be maintained that, is, that the AIICO management should withdraw its letter of redundancy from all the affected employees and that these employees should be allowed to return to their respective offices without let or hinderance and without any loss of pay in their salaries and allowances.
