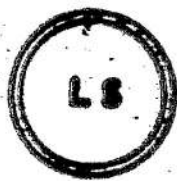

- “(i) Flagrant violation of Labour Decree 1974, Section 10 ;
- (ii) Victimisation and mal-treatment of workers—declaring them as Temporary Workers.”

and to make such award, having regard to the circumstances of the dispute, and such other matters pertaining thereto or arising therefrom as the National Industrial Court may deem necessary.
