

ACT No. 13

A LAW TO AUTHORISE THE ISSUE OUT OF THE CONSOLIDATED REVENUE FUND OF PLATEAU STATE THE SUM OF TWENTY BILLION, FOUR HUNDRED AND EIGHTY MILLION, NINE HUNDRED AND FIFTY-SIX THOUSAND, THREE HUNDRED AND SEVENTY-THREE NAIRA (N20,480,956,373) FOR THE SERVICE OF THE STATE IN RESPECT OF THE FINANCIAL YEAR COMMENCING ON 1ST JANUARY AND ENDING ON 31ST DECEMBER. 2004 [30th June, 2004] ENACTED by the National Assembly of the Federal Republic of Nigeria-1. This Law may be cited as the Appropriation Law 2004.

2. This Law is deemed to have come into effect on the 1^e January, 2004.

3.—(1) The Accountant-General of the State may, when authorized to do so by warrants signed by the Commissioner charged with responsibility for finance, pay out of the Consolidated Revenue Fund of the State during the financial year ending 31^a December, 2004 the sum not exceeding in the aggregate twenty billion four hundred and eighty million, nine hundred and fifty-six thousand, three hundred and seventy three Naira.

(2) The amount mentioned in subsection (1) of this section shall be appropriated to heads of expenditure as indicated in the Schedule to this Law.

(3) No part of the amount shall be issued out of the Consolidated Revenue Fund of the State after the end of the year mentioned in subsection (1) of this section.
