# FEDERAL CAPITAL TERRITORY STATUTORY APPROPRIATION ACT 2006

## 2006 ACT No.3

AN ACT TO AUTHORISE THE ISSUE FROM THE CONSOLIDATED REVENUE FUND OF THE FEDERATION ACCOUNT AND OTHER ACCOUNTS OF THE FEDERAL CAPITAL TERRITORY, THE TOTAL SUM OF ₦52,581,143,442.00K (FIFTY-TWO BILLION, FIVE HUNDRED AND EIGHTY-ONE MILLION, ONE HUNDRED AND FORTY-THREE THOUSAND, FOUR HUNDRED AND FORTY-TWO NAIRA) ONLY OF WHICH THE SUM OF ₦12,118,708,157.00K (TWELVE BILLION, ONE HUNDRED AND EIGHTEEN MILLION, SEVEN-HUNDRED AND EIGHT THOUSAND, ONE HUNDRED AND FIFTY SEVEN NAIRA) ONLY, IS FOR PERSONNEL COSTS AND THE SUM OF ₦5,101,883,550.00K (FIVE BILLION, ONE-HUNDRED AND ONE MILLION, EIGHT HUNDRED AND EIGHTY-THREE THOUSAND, FIVE HUNDRED AND FIFTY NAIRA) ONLY IS FOR OVERHEAD COSTS WHILST THE BALANCE OF ₦35,360,551,735.00K (THIRTY-FIVE BILLION, THREE HUNDRED AND SIXTY MILLION, FIVE HUNDRED AND FIFTY-ONE THOUSAND, SEVEN HUNDRED AND THIRTY-FIVE NAIRA) ONLY IS FOR CAPITAL PROJECTS FOR THE SERVICE OF THE FEDERAL CAPITAL TERRITORY ABUJA, FOR THE YEAR ENDING 31ST DECEMBER, 2006.

ENACTED by the National Assembly of the Federal Republic of Nigeria :

1.—(1) The Accountant-General of the Federation shall, when authorised to do so by warrants signed by the Minister Charged with responsibility for Finance, pay out of the Consolidated Revenue Fund of the Federation during the Year 2006 the sum specified by the warrants, not exceeding in the aggregate ₦52,581,143,442:00k (fifty two billion, five hundred and eighty one million, one hundred and forty three thousand, four hundred and forty two Naira) only.

(2) The amount mentioned in sub-section (1) of this section shall be appropriated to heads of Expenditure as indicated in the Schedule to this Act.

2. All amounts appropriated under this Act shall be made from the Consolidated Revenue Fund only for the purposes specified in the Schedule to this Act.

3.—(1) All revenues accruing to the Territory other than the Statutory Revenue distribution shall be paid into a dedicated Account of Federal Capital Territory.

(2) No monies shall be withdrawn from the Account mentioned in section 3(1) without appropriation by the National Assembly.

4. In the event that the implementation of any of the projects intended to be undertaken under this Act cannot be completed without virement, such virement shall only be effected with the prior approval of the National Assembly.

5.—(1) The Accountant-General of the Federation and the Governor of Central Bank of Nigeria shall immediately upon the coming into force of this Act furnish the National Assembly, on a monthly basis, the status of the records of the Federal Capital Territory Statutory Accounts.

(2) All accounting Officers of the Federal Capital Territory Administration, Agencies, Parastatals and Extra-Ministerial Departments who control heads of expenditure shall present to the National Assembly quarterly reports detailing the progress of implementation of the provisions of this Act.

**Waiver not to incur Expenditure.**

6. Where, due to revenue shortfall, amounts appropriated under this Act cannot be funded, the Minister of Federal Capital Territory shall seek from the National Assembly a waiver not to incur such expenditure.

**Short Title.**

7. This Act may be cited as the Federal Capital Territory Appropriation Act, 2006.
