FEDERAL REPUBLIC OF NIGERIA

THE CONSTITUTION OF THE FEDERAL REPUBLIC OF NIGERIA, 1999 (AS ALTERED)

Whereas by Section 260(2) of the Constitution of the Federal Republic of Nigeria, 1999 (as altered), it is provided that the Sharia Court of Appeal of the Federal Capital Territory, Abuja shall consist of a Grand Kadi of the Sharia Court of Appeal and such number of Kadis of the Sharia Court of Appeal, as may be prescribed by an Act of the National Assembly of the Federal Republic of Nigeria;

Whereas by Section 261(1) of the Constitution of the Federal Republic of Nigeria, 1999 (as altered), it is provided that the appointment of a person to the office of a Grand Kadi of the Sharia Court of Appeal of the Federal Capital Territory, Abuja shall be made by the President on the recommendation of the National Judicial Council, subject to the confirmation by the Senate;

AND WHEREAS it is necessary that the instrument in evidence of the aforesaid appointment of the Grand Kadi of the Sharia Court of Appeal of the Federal Capital Territory, Abuja be executed by the authority now competent to make such appointment;

Now Therefore, I, DR. GOODLUCK EBELE JONATHAN, President of the Federal Republic of Nigeria, acting on the recommendation of the National Judicial Council, do hereby appoint Honourable Kadi Ibrahim Abba as the Grand Kadi of the Sharia Court of Appeal of the Federal Capital Territory, Abuja with effect from the 15th day of December, 2014.
