



AN ACT TO AMEND THE NIGER DELTA DEVELOPMENT COMMISSION (ESTABLISHMENT, ETC.) ACT, NO. 6, 2000 TO INCREASE THE FUNDING OF THE COMMISSION FOR EFFECTIVE DISCHARGE OF ITS DUTIES ; AND FOR RELATED MATTERS.

[29th Day of December, 2017] Commence

ENACTED by the National Assembly of the Federal Republic of Nigeria-

1. The Niger Delta Development Commission (Establishment, Etc.) Act No. 6, 2000 (in this Act referred to as "the Principal Act") is amended as set out in this Act.

2. Section 14 (2) of the Principal Act is amended, by substituting for paragraph (b), a new paragraph "(b)"----

"(b) 3 percent of—

(*i*) the total annual budget of any oil producing company operating onshore and offshore, in the Niger Delta area ; and

(*ii*) the total annual budget of any gas processing company in the Niger Delta area, excluding the cost of feed gas."

3. This Act may be cited as the Niger Delta Development Commission Citation. (Establishment, Etc.) (Amendment) Act, 2017.
