



OIL TERMINAL DUES ACT (CAP. 08 LFN, 2004

ESCRAVOS OIL TERMINAL (ESTABLISHMENT) AMENDMENT ORDER, 2018

[12th Day of October, 2018]

Commencement.

In exercise of the power conferred upon me by section 7, subsection (2) of the Oil Terminal Dues Act and all other powers enabling me in that behalf, I MUHAMMADU BUHARI, President, Federal Republic of Nigeria and Minister of Petroleum Resources, make the following Order—

1. The Escravos Oil Terminal (Establishment) Order, 1965 (in this Order referred to as "the Escravos Order") is amended as follows:

Amendment of the Escravos Oil Terminal (Establishment) Order, 1965

2. Paragraph 2 of the Escravos Order is amended by replacing paragraph 2(b) and (c) with a new paragraph 2(b) and (c) as follows:

Amendmen of Paragrap 1 2 of the Excravos Order.

"(b) Parcel B: all that parcel of land at Ugborodo, Escravos Bar in the Warri North West Local Government Council, Delta State, Nigeria, containing an area of approximately 290.056 acres (being the combination of the erstwhile parcel B with area of 6.586 acres and the Escravos Gas to Liquid (EGTL) land with area of 283.477 acres) the boundaries of which are described below:

Starting at a concrete pillar marked MW 33 the co-ordinates of which are 178205.733mN and 307949.328mE the boundary runs in a North-Easterly direction in a clockwise orientation as depicted in the table below:

(c) The Offshore Safety Exclusion Zone: All that sea area offshore from Ugborodo, Escravos Bar, in Warri North West Local Government Council, Delta State, Nigeria, containing an area of approximately 18081.29 acres and comprising the erstwhile Offshore Berth 1, Offshore Berth 2 and Offshore Berth 3 together with the new EGTL Offshore Berth bounded by the following co-ordinates:
