

PUBLIC ENTERPRISES (PRIVATISATION AND COMMERCIALISATION) ORDER, 2018

In exercise of the powers conferred on it by section 1 (3) of the Public Enterprises (Privatisation and Commercialisation) Act, and all other powers enabling it in that behalf, the National Council on Privatisation makes the following Order—

1. Part I of the First Schedule to the Act is amended by adding the following Enterprises to the list of Enterprises listed for Partial Privatisation—

(a) Atam Three Power Limited;

(b) Kano Free Trade Zone; and

(c) Calabar Free Trade Zone.

2. This Order may be cited as the Public Enterprises (Privatisation and Cita Commercialisation) Order, 2018.
