In exercise of the powers conferred on it by sections 25 and 29 (1) of the Council for the Regulation of Freight Forwarding in Nigeria and all other powers enabling it in that behalf, the Council, with the approval of the Honourable Minister of Transportation, makes the following Regulations—

1. The Council for the Regulation of Freight Forwarding in Nigeria (CRFFN)(Annual Subscription and Other Fees) Regulations, 2010, as amended in 2015 (“the Principal Regulation”) is further amended as set out in these Regulations.

2. There is inserted into the Principal Regulation the following new regulation 6—

6. Collection and disbursement of Practitioners’ Operating Fee (POF)—

(1) The Council shall collect and disburse all POF.

(2) The Council shall disburse the monies collected in accordance with sub-regulation (1) of this regulation as follows—

(a) 65% as Internally Generated Revenue (IGR) to the Federal Government; and

(b) 35% to the Registered Freight Forwarder and Customs Licensed Agent (RFF and CLA) who made the declaration through the Accredited Associations,

as provided under the Council for the Regulation of Freight Forwarding in Nigeria (Accreditation of Associations of Freight Forwarders) Regulations, 2010.

(3) The airports cargo handling companies for airfreight and the sea-ports Terminal Operators shall ensure, as a pre-condition for the release of cargo from the Ports that, the Practitioners’ Operating Fee is paid by a Registered Freight Forwarder or Custom’s Licensed Agent.

Re-numbering of the existing regulations 6, 7, 8 and 9.

3. The Principal Regulation is amended by re-numbering the existing regulations 6, 7, 8 and 9 as regulations 7, 8, 9 and 10.

Power to amend or revoke these Regulations.

4. The Council may, from time to time amend or revoke the provisions of these Regulations.

Amendment of the Third Schedule to the Principal Regulations as amended in 2015.

5. The Third Schedule to the Principal Regulations, as amended in 2015, is further amended as follows—
