ENACTED by the National Assembly of the Federal Republic of Nigeria—

1. The Orthopaedic Hospitals Management Board Act, Cap. O10 Laws of the Federation of Nigeria 2004 (in this Act referred to as “the Principal Act”) is amended as set out in this Act.

EXPLANATORY MEMORANDUM

This Act amends the Orthopaedic Hospitals Management Board Act Cap. O10 Laws of the Federation of Nigeria, 2004 to provide for the establishment of the Orthopaedic Hospitals Benin, Edo State and Jalingo, Taraba State under the control of the Orthopaedic Hospitals Management Board and affiliated to the University of Benin Teaching Hospital and University of Maiduguri Teaching Hospital respectively, to provide specialised Orthopaedic treatment and medical services.
