#### NATIONAL PARKS AND NATURE CONSERVANCY ACT

(Cap 141)

#### National Parks Fees (Amendment) Regulations, 2020

In exercise of the powers conferred by section 16(a) of the National Parks and Nature Conservancy Act, Cap 141, the Minister responsible for national parks and nature conservancy makes the following regulations—

1. These Regulations may be cited as the National Parks Fees (Amendment) Regulations, 2020.

2. Regulation 17(2) of the National Parks (Ste. Anne Marine) Regulations, 1973, is amended by deleting the words "Rs.50" and substituting therefor with the words "SCR 200".

**3.** The National Parks (Cousin Island Special Reserve) Regulations, 1979, is amended by repealing regulation 10 and replacing it with the following—

Fees.

**"10.**(1) I.C.B.P. may, with the agreement of the Commission, impose a fee or charge of a maximum of SCR 600 in its discretion impose a fee for entry into the Reserve.

(2) I.C.B.P. may, with the agreement of the Commission, make such provision as it thinks fit for the imposition and collection of fees for performance of acts in the Reserve or services provided by it in relation to the Reserve." Citation

7. Regulation 14(1) of the National Parks (Baie Ternay Marine) Regulations, 1997, is amended by deleting the words "R.100" and substituting therefor with the words "SCR 200".

**8.** Regulation 15(1) of the National Parks (Ile Cocos, Ile La Fouche, Ilot Platte) Regulations, 1997, is amended by deleting the words "R 100" and substituting therefor with the words "SCR 200".
