Securities (Forms and Fees)(Amendment) Regulations, 2020

In exercise of the powers conferred by section 133 of the Securities Act, the Minister responsible for finance on the recommendation of the Securities Authority, makes the following regulations —

MUTUAL FUND AND HEDGE FUND ACT

(Cap 285)

Mutual Fund and Hedge Fund (Amendment of Schedule 1) Regulations, 2020

In exercise of the powers conferred by section 34 of the Mutual Fund and Hedge Fund Act, the Minister of finance makes the following regulations—

- 1. These regulations may be cited as the Mutual Fund and Hedge Fund (Amendment of Schedule 1) Regulations, 2020.
- **2.** Schedule 1 to the Mutual Fund and Hedge Fund Act is repealed and replaced with the following —

- (f) an application for a restricted mutual fund administrator's licence: \$1000;

(g) an exemption application under section 8(2) from the requirement to obtain a fund administrators licence: \$1500.

- (b) Professional Fund: \$1250;
- (c) Public Fund: \$1500;
- (d) annual renewal of exemption for an exempt foreign fund under section 3(17) from the requirement to obtain a fund licence (payable as from the expiry of one year from the date of issuance of approval to the initial exemption application and annually thereafter): \$2000;
- (e) annual fund administrator's licence fee: \$2000;
- (f) annual restricted fund administrator: \$1500;
- (g) annual exemption renewal under section 8(5) from the requirement to obtain a fund administrator's licence (payable as from the expiry of one year from the date of issuance of approval to the initial exemption application, and annually thereafter): \$2000.

3. Miscellaneous fees

- (a) application by public fund for approval under section 7(1) of a proposed offering document or amended offering document, as the case may be: \$500;
- (b) Fee for search under section 4(4) of the public register (licensed funds or exempt foreign funds): \$150;
- (c) Fee for search under section 11(12) of the public register (licensed fund administrators or approved foreign administrators: \$150;

- (d) Fee per page for obtaining a copy of any document available on the public search of the register: \$2.50 per page;
- (e) Fee per official search under section 4(5) or 4(6): \$200;
- (f) Fee per official search under section 11(13) or 11(14): \$200."
