AN ACT TO AMEND THE TRUTH, RECONCILIATION AND NATIONAL UNITY COMMISSION ACT, 2018 (ACT 9 OF 2018) TO EXTEND THE MANDATE AND TERM OF THE TRUTH, RECONCILIATION AND NATIONAL UNITY COMMISSION.

**ENACTED** by the President and the National Assembly.

#### Short title

1. This Act may be cited as the Truth, Reconciliation and National Unity Commission (Amendment) Act, 2022, and amends the Truth, Reconciliation and National Unity Commission Act, 2018 ("the principal Act").

#### Amendment of section 11

2. Section 11(2) of the principal Act is amended by repealing the words "and shall submit its final report within three months after it has completed its inquiries".

#### Amendment of section 14

- **3.**(1) Section 14(1) of the principal Act is amended by repealing the words "and shall end upon the delivery to the President of its final report".
- (2) Section 14(2) of the principal Act shall be substituted for the following
  - "(2) The mandate of the Commission shall come to an end on 31 December, 2022, or on the date on which the Commission delivers its final report to the President of the Republic of Seychelles, whichever is the earlier."

# Validity of decisions

4. Any action or decision taken by the Commission between 9 August 2022 and the date on which this Act commences shall be valid and deemed to have been properly made under the principal Act as if the mandate of the Commission had been extended as from 9 August 2022.

# PUBLIC HEALTH ACT, 2015

(Act 13 of 2015)

# Public Health (Emergency Use Authorisation of Vaccines and Medical Products) (Amendment) Regulations, 2022

In exercise of the powers conferred by section 26of the Public Health Act, 2015, the Minister responsible for health, makes the following regulations —

#### Citation

1. These Regulations may be cited as the Public Health (Emergency Use Authorisation of Vaccines and Medical Products) (Amendment) Regulations, 2022.

## Amendment of S.I. 14 of 2021

2. Schedule 2 to the Public Health (Emergency Use Authorisation of Vaccines and Medical Products) Regulations, 2021 is hereby amended by inserting after item 5the following item —

#### **"6. AUTHORISED VACCINE**

- 1. Name of Vaccine: Pfizer BioNTech COVID 19 mRNA Vaccine (nucleoside modified) for children aged 5 to 11 years;
- 2. Commercial Name: COMIRNATY® (Tozinameran)
- 3. Manufacturer: Pfizer, USA
- 4. Date of Authorisation:
- 5. Use for the Prevention of: Coronavirus Disease 2019 caused by SARS-COV-2.".

# **Short title**

1. This Act may be cited as the Trusts (Amendment) Act, 2022.

## Amendment of section 26 of Act 34 of 2021

**2.** Section 26 of the Trusts Act, 2021 (hereinafter referred to as the "principal Act") is amended in subsection (4), by repealing the word "censed".

# Insertion of new section 30A

**3.** The principal Act is amended, by inserting after section 30, the following section —

# "Request of information between trustees

- **30A.**(1) Where a trust is administered by more than one trustee, any trustee may request any relevant information in respect of the trust from any of the other trustees of the trust.
- (2) Pursuant to section 16 of the Beneficial Ownership Act, 2020 (Act 4 of 2020), subsection (1) shall also apply to information on beneficial owners.
- (3) A trustee shall comply with a request for information made under subsection (1) within the time specified in the request."

## Amendment of section 84

**4.** Section 84 of the principal Act is amended in subsection (4) by repealing the word "rty".

#### Amendment of section 89

5. Section 89 of the principal Act is amended in paragraph (1)(a) by inserting after the words "access the" the words "registered office or".

#### Citation

1. These regulations may be cited as the Public Health Authority (Amendment of Third Schedule) Regulations, 2022.

#### **Amendment of Third Schedule**

2. The Third Schedule to the Public Health Authority Act, 2013, is amended in paragraph 1 by repealing the words "but shall not be eligible to hold office for more than two terms".

# PREVENTION OF TERRORISM (AMENDMENT) ACT, 2022

(Act 21 of 2022)

AN ACT TO AMEND THE PREVENTION OF TERRORISM ACT, CAP. 179, TO MAKE PROVISION FOR THE NEED FOR COMMUNICATIONS MADE TO FINANCIAL INSTITUTIONS AND DESIGNATED NON-FINANCIAL BUSINESSES OR PROFESSIONS TO BE DONE WITHOUT DELAY; TO ENSURE ORDERS MADE BY THE MINISTER TO PROHIBIT FUNDS BEING MADE AVAILABLE TO PERSONS LIVING IN FOREIGN STATES TO COMMIT CRIMES UNDER THIS ACT ARE CARRIED OUT IMMEDIATELY UPON DESIGNATION BY THE RELEVANT UN SANCTIONS COMMITTEE.

**ENACTED** by the President and the National Assembly.

#### Short title

This Act may be cited as the Prevention of Terrorism 1. (Amendment) Act, 2022.

# Amendment of section 20E (Act 8 of 2021) Cap.179

- **2.** Section 20E of the Prevention of Terrorism Act Cap.179 (hereinafter referred to as the principal Act) is hereby amended in
  - (a) subsection (3) by the insertion of the words "without delay" after the word "communicated";
  - (b) subsection (4) by the insertion of the words "or other actions taken in compliance with the requirements of the relevant UNSCRs, including attempted transactions" after "subsection (1)".

# Amendment of section 20H (Act 8 of 2021) Cap.179

- 3. Section 20H is amended by the repeal of subsection (1) and substituted by
  - **"20H.**(1) Where a person living outside Seychelles has been designated by the relevant UN Sanctions Committee, the Minister shall, by Order published in the Gazette, prohibit
    - (a) all persons in Seychelles (including non-Seychellois);
    - (b) all citizens of Seychelles residing outside Seychelles;

from making funds available to, or for the use or benefit of, the first mentioned person who shall be named in the Order or be identified by reference to a description of persons set out in the Order."
