The decision referred to in paragraph 2 shall be given effect through a refinancing arrangement, by which Mauritius Commercial Bank (Seychelles) Ltd has agreed to enter into a new term loan facility agreement with the Government of the Republic of Seychelles (“the loan agreement”), such that the Government of the Republic of Seychelles shall become the counterpart to the agreement.
