S.I. 40 of 2023**STAMP DUTY ACT***(Cap 227)***Stamp Duty (Exemption) (Amendment) Order, 2023**

In exercise of the powers conferred by section 47 of the Stamp Duty Act, the Minister responsible for finance makes the following Order —

Citation

1. This Order may be cited as the Stamp Duty (Exemption) (Amendment) Order, 2023.

Amendment of S.I. 51 of 2019

2. The Stamp Duty (Exemption) Order, 2019 is amended as follows —

(a) in regulation 3 —

(i) in subregulation (2), by repealing paragraph (c) and substituting it with the following new paragraph —

“(c) the exemption is applicable provided a consideration or value of up to Seychelles rupees three million (SCR 3,000,000/-)”

(ii) in subregulation (3), by repealing paragraph (b) and substituting it with the following new paragraph —

“(b) the exemption is applicable provided a consideration or value of up to Seychelles rupees one million and five hundred thousand (SCR1,500,000.00/-)”

- (b) in the third schedule, by repealing the words “transferred or” at item (iii).

Citation and commencement

1. This order may be cited as the Immovable Property Tax (Increase in Tax Rate) Order, 2023 and shall come into operation on the 1st January, 2024.

Increase in Tax Rate

2. The tax rate of the market value of any immovable property liable to be taxed is hereby increased from 0.25% to 0.50%.
