IMMIGRANTS TO SIERRA LEONE FROM LEBANON ETC.

It is announced from the Office of the President that the Government views with growing concern the large numbers of immigrants to Sierra Leone, principally from Lebanon, within the past six months. It has come to the notice of Government that most of these immigrants have arrived in the country without having previously obtained visas and that in the great majority of cases, the Immigration Authorities have been finding much difficulty in tracking those who, on arrival, were given entry visas for visits of between one to three months.

The Government wishes to make it publicly and widely known that the Principal Immigration Officer has been given strict instructions not to allow anyone to land in Sierra Leone for purposes of sojourn, irrespective of the duration of the stay, without a valid entry visa having previously been obtained.

The Government also desires to make it abundantly clear to all Airlines operating in Sierra Leone that no passenger from flights operated by those Airlines will be allowed to land in the country without a valid entry visa having previously been obtained. Any contravention of this instruction will be the direct responsibility of the Airline concerned and such Airline will automatically have to fly back the passenger concerned on the same flight.

The proceeds of the loan will be used to finance the Development Projects for the country. This issue is authorised by the Development Loans Act, 1965.

#### ALLOTMENT

The Bank of Sierra Leone, after consultation with the Minister of Finance, will allot the Stock as soon as practicable after the 8th October, 1976. No allotment will be made for an amount less than Le10. Registered Stock Certificates will be issued in due course through the banks at which applications were made. Letters advising amounts of Stock allotted will be forwarded to applicants direct by the Bank of Sierra Leone.

Money received on application in excess of the amount of the Stock allotted to an applicant will be refunded.

# INTEREST

The first interest payment will be made on the 11th April, 1977 at the rate of 81% per annum and thereafter, half-yearly on the 11th October and 11th April each year until maturity.

#### REGISTER

A Register of the holders of the Stock will be maintained by the Bank of Sierra Leone.

#### TRANSFER

Stock will be transferable in multiples of Le10 by means of a transfer in common form. Transfers will be free of stamp duty.

#### SINKING FUND

The Government is required to make provision for the payment of the Stock on the due date setting up Sinking Fund in compliance with Section 24 of the Government Loans Act, 1965. The contribution will be of an amount sufficient to ensure that approximately 80% of the fund required at maturity, after allowing for the proceeds of such conversion offer as may be made to subscribers at that time, will be met from the resources of the Government of Sierra Leone.
