THE ACCOUNTANT-GENERAL

You are hereby authorised to pay from the Consolidated senue Fund of Sierra Leone during the Financial Year 1985/ such sums as may be necessary during the year, the Personnel of the Expenditures enumerated in the Schedule hereto nexed, as may be authorised by the Minister of Finance up the total of Le349,628,456.

And for so doing, this together with the Accounts, Certificates Acquittances prescribed in the laws and instructions of arra Leone, shall be your sufficent Warrant and discharge.

This Warrant also authorises the officers controlling the enditure votes, as enumerated in the approved Estimates to ur expenditure under the Heads and Sub-heads under their trol as set out in the schedule hereto annexed.

Provided that such officers may incur such expenditure only to the extent authorised in allotment Warrants which may be issued quarterly or from time to time by the Financial Secretary acting under my direction, as further described in Financial Circular No. 3 of 1972.
