## NOTICE TO CONTRACTORS

Further to Government Notice No. 263 published in the Sierra Leone Gazette No. 46 Vol. CXVII of 12th June, 1986, the Contractors Registration Board now wished to publish a Revised List of Registered Contractors eligible to tender for Government and other contracts. The list will include the contractors name and address, Financial Class and Works Category.

Henceforward, tenders for a particular work category will be invited only from Contractors Registered in that category and in the Financial Class allotted to them. The Financial classes and works Categories are defined as follows:

## WORKS CATEGORIES

## WORKS CATEGORY 'A' MINOR ENGINEERING WORKS

This category includes construction of Chiefdom tracks, services, access and feeder roads up to class IV standard, small bridges, jetties and other minor Civil Engineering works.

## WORKS CATEGORY 'B' CIVIL ENGINEERING WORKS

This category includes construction of class III to class I roads, major bridges special foundation and pilling works water works, sewage works and all major civil engineering works. Firms in this category should possess adequate machinery for the nature of work in which they are engaged.

## WORKS CATEGORY 'C' SPECIAL BUILDING WORKS

This category includes multi-storey buildings above 4 storeys, buildings requiring unusual forms of construction and/or fittings and furnishing of very high standards and/or complex foundations or subsurface structures.

## WORKS CATEGORY 'D' GENERAL BUILDING WORKS

This category includes Buildings of a straightforward construction and finish together with customary ancillary buildings and external works.
