Act No. 7 of 2009 entitled—"The Bankruptcy Act, 2009"— Being an Act to provide for declaring as bankrupt any person who cannot pay his debts of a specified amount and to disqualify him from holding certain elective and public offices or from practising any regulated profession and to provide for other related matters.


