THE POSTAL (AMENDMENT) REGULATIONS, 1983
(Under Regulation 4)
In exercise of the powers conferred by regulation 4 of the Post Office Act, 1962, the Minister for Works, Power and Communications hereby makes the following Regulations-

## Citation.

1. These Regulations may be cited as the Postal (Amendment) Regulations, 1983 and shall be read as one with the Post Office Regulations, 1962.

LEGAL NOTICE NO. 20 OF 1983

THE COTTON ACT, 1967
(Act No. 26 of 1967)
THE COTTON LEVY NOTICE, 1983
(Under section 13)
In exercise of the powers conferred by section 13 of the Cotton Act, 1967, the Minister for Agriculture hereby issues the following Notice:-

## Citation.

1. This Notice may be cited as the Cotton Levy Notice, 1983.

Imposition of levy on 1982/83.
2. There is hereby imposed a levy of $\mathbf{0 . 5 0}$ of one cent per kilogramme of seed-cotton produced by every grower in respect of the 1982/83 season.

Date before which payment to be made.
3. The levy imposed by paragraph 2 shall be paid before the 1st December, 1983.

## Method of payment.

4. The levy imposed by paragraph 2 and any surcharge there on under section 13(6) of the Cotton Act, 1967 shall be paid at the option of the grower to:-
(a) the Executive Officer of the Cotton Board; or
(b) any of the following ginners who in accordance with section 13(7) of the Cotton Act, 1967 have agreed with the Board to deduct the amount of the levy from the purchase price of the seed-cotton purchased and to pay the amount to the Executive Officer, namely:
(i) Swaziland Cotona Ginning Company Ltd;
(ii) J.L. Clark Cotton Company (Pty) Ltd.;
(iii) Swaziland Oil Seeds Mills (Pty) Ltd;
(iv) Swaziland Cotton Co-operative Society Ltd.

Recovery of levy.
5. The Board may recover from a grower any unpaid levy and surcharge under section 13 of the Cotton Act, 1967 as debt payable to the Board.

Revocation of Legal Notice No. 43 of 1979.
6. The Cotton (Levy) Regulations 1979 are hereby revoked.
