LEGAL NOTICE NO. 1 OF 1985

THE CANE GROWERS ACT, 1967

(Act No. 12 of 1967)

THE IMPOSITION OF LEVY ON SUGAR CANE GROWERS NOTICE, 1985

(Under Section 4)

In exercise of the powers conferred by Section 4 of the Cane Growers Act, 1967, the Minister for Agriculture and Co-operatives on the recommendations of the Swaziland Cane Growers' Association hereby issues the following Notice—

Citation and commencement.

1. This Notice may be cited as the Imposition of Levy on Sugar Cane Growers Notice, 1985 and shall be deemed to have come into force on the 1st May, 1984.

Rate of Levy.

2. The Levy shall be at the rate of E0.65 per metric ton supplied to, and accepted, by a miller during the period from the 1st May, 1984 to the 30th April, 1985.

Due date of levy.

- 3. (1) The due date of the levy in respect of each delivery of sucrose during any mill month shall be the tenth day after the last day of such mill-month.
- (2) In the absence of satisfactory proof to the contrary the miller shall be deemed to have accepted sucrose on the date of delivery of such sucrose to him.
- (3) For the purpose of this Notice, "mill-month" shall have the meaning assigned to it by the Schedule to the Sugar Act, 1967.

Method of payment of levy.

4. Millers shall deduct the amount of levy on each sugar cane grower from the periodic payments made to such grower for sucrose supplied by him and shall remit the amount of such levy to the Swaziland Cane Growers' Association by the due date.

LEGAL NOTICE NO. 2 OF 1985

THE SWAZILAND ROYAL INSURANCE CORPORATION ORDER, 1973

(Order No. 32 of 1973)

THE SWAZILAND ROYAL INSURANCE CORPORATION (DIRECTORS' FEES) NOTICE, 1985

(Under Section 12)

In exercise of the powers conferred by section 12 of the Swaziland Royal Insurance Corporation Order, 1973 the Minister for Finance hereby issues the following Notice—

Citation and commencement

1. This Notice may be cited as the Swaziland Royal Insurance Corporation (Directors' Fees) Notice, 1985 and shall be deemed to have come into force on 1st January, 1985.

Payment of fees to Directors.

- 2. (1) A fee of E2,000 and E2,500 per annum shall be paid to a Director or Chairman respectively of the Swaziland Royal Insurance Corporation appointed as such under section 7 of the Swaziland Royal Insurance Order, 1973.
- (2) If a Director or Chairman serves for a period which is less than one year, he shall be paid the pro rata portion of the amount specified in sub-paragraph (1) for the period of such service.
- (3) Nothing in this Notice shall be construed to mean that any renumeration shall be paid to a public Officer appointed as such to act as a Director.

Revocation of Legal Notice No. 10 of 1984.

3. The Swaziland Royal Insurance Corporation (Directors' Fees) Notice, 1984 is hereby revoked.
