LEGAL NOTICE NO. 24 OF 1985

THE CROWN LANDS DISPOSAL ACT, 1911

(Act No. 13 of 1911)

THE MBABANE (EXTENSION NO. 13) TOWN REGULATIONS, 1985

(Under Section 12)

In exercise of the powers conferred by section 12 of the Crown Lands Disposal Act, 1911 the Minister for Natural Resources, Land Utilization and Energy hereby makes the following Regulations —

Citation.

1. This Notice may be cited as the Mbabane (Extension No. 13) Town Regulations, 1985.

Establishment of town and alteration of general plan.

2. (1) Farm No. 1257 situate in the Hhohho District, Measuring 595,3652 (five nine five comma three six five two) hectares in extent:

held by the Crown under Certificate of Registered Crown Title No. 59/1965 dated 26th February, 1965 comprising 174 (one hundred and seventy four) lots numbered 1649 to 1822 including roads as will more fully appear from General Plan S.G. No. S. 89/80 approved by the Surveyor-General on the 22nd February, 1980, is hereby proclaimed to be and established as a town.

(2) The Surveyor-General shall alter the General Plan so as to indicate the name and lot numbers assigned under these Regulations for the Town and shall endorse the General Plan of the Town of Mbabane and General Plan S.G. No. S. 89/80 accordingly.

- (3) The Registrar of Deeds shall —

- (a) make such endorsement on the relevant title deeds as may be necessary; and
- (b) open the necessary register in connection with the Town.

LEGAL NOTICE NO. 25 OF 1985

THE ROAD TRANSPORTATION ACT, 1963

(Act No. 37 of 1963)

THE ROAD TRANSPORTATION (AMENDMENT) REGULATIONS, 1985

(Under Section 28)

In exercise of the powers conferred by section 28 of the Road Transportation Act, 1963 the Minister for Works and Communications hereby makes the following Regulations—

Citation.

1. These Regulations may be cited as the Road Transportation (Amendment) Regulations, 1985, shall be read as one with the Road Transportation Regulations, 1964 and shall come into force on the 1st May, 1985.

Replacement of First Schedule.

2. The First Schedule to the Road Transportation Regulations, 1964 is replaced with the following new Schedule —
