



LEGAL NOTICE NO. 40 OF 1985

THE PRISONS ACT, 1964 (Act No. 40 of 1964)

THE PRISONS (AMENDMENT) REGULATIONS, 1985 (Under section 64)

In exercise of the powers conferred by section 64 of the Prisons Act, 1964, the Minister for Justice makes the following Regulations —

Citation and commencement.

1. These Regulations may be cited as the Prisons (Amendment) Regulations, 1985 and shall be read as one with the Prisons Regulations, 1964 and shall be deemed to have come into force on the 25th March, 1985.

Replacement of section 36.

- 2. Section 36 of the Prisons Regulations, 1964 is replaced with the following -
 - "36. (1) Subject to section 33 and to this regulation, the officer in charge shall supply a prisoner with a diet under Scale A of the First Schedule.
 - (2) The officer in charge shall conspicuously display a copy of Scale A and B in the prison.
 - (3) After obtaining the written advice of the prison medical officer the officer in charge may reduce the diet of a prisoner who persistently wastes his food.
 - (4) Unless the prison medical officer recommends otherwise, a prisoner lawfully subjected to a penal diet shall have the penal diet under Scale B of the First Schedule in place of his normal diet.

Provided that if the Prisoner is subjected to the penal diet for more than three days this diet shall consist of the diet under —

- (i) Scale B, for the first three days;
- (ii) Scale A, for the next three days; and
- (iii) Scale B, thereafter.
- (5) No prisoner who has been subjected to a penal diet for a day shall perform a task of labour:

Except that he may be allowed to perform minimal work in his cell.

- (6) A prisoner may only be subjected to a penal diet for a fresh offence after the period he has already spent on penal diet has elapsed.
- (7) The officer in charge shall count the days a prisoner spends on normal diet towards the total period of penal diet the prisoner has been subjected to.

Replacement of First Schedule.

3. The First Schedule of the Prisons Regulations, 1964 is replaced with the following —
