THE POST OFFICE ACT, 1962

(Act No. 60 of 1962)

THE POSTAL PARCEL POSTAGE RATES (AMENDMENT) REGULATIONS, 1985

(Under section 105)

In exercise of the powers conferred by section 105 of the Post Office Act, 1962 the Minister for Works and Communications hereby makes the following Regulations—

Citation and commencement.

1. These Regulations may be cited as the Postal Parcel Postage Rates (Amendment) Regulations, 1985 and shall be read as one with the Postal Regulations, 1962 and shall come into force on the 1st May, 1985.
