CORRIGENDUM

THE INCOME TAX (CONSOLIDATION) (AMENDMENT) BILL, 1985

(Bill No. 7 of 1985)

The Income Tax (Consolidation) (Amendment) Bill, 1985 should be corrected as follows:-

1. *In Clause 10—*
 - (a) paragraph (a) should read as follows—
 - “(a) by replacing the words “losses” and “outgoings” with the words “expenditure” and “loss”, respectively;”
 - (b) in paragraph (b) by placing in brackets the words “excluding a taxpayer who derives income from the sale of immovable property to persons who are not employed by him” which appear in the proposed new paragraph (g).
2. *In Clause 12 (which seeks to introduce a new Division III relating to Entertainers and Sportsmen)—*
 - (a) in paragraph 32A (4) by replacing the word “Act” with the word “Order”; and
 - (b) in paragraph 32A (5) by replacing the word “with” with the word “within”.
3. *In Clause 15,* by inserting after the word “woman” in the proposed section 36(1) the words “deemed to”.
