LEGAL NOTICE NO. 64 OF 1985

THE ANIMAL DISEASES ACT, 1965

(Act No. 7 of 1965)

THE STOCK DISEASES (RABIES) REGULATIONS, 1985

(Under section 3)

In exercise of the powers conferred by section 3 of the Animal Diseases Act, 1965 the Minister for Agriculture and Co-operatives hereby makes the following Regulations —

Citation and commencement.

1. These Regulations may be cited as the Stock Diseases (Rabies) Regulations, 1985 and shall come into force on the June, 1985.

Declaration of rabies guard areas.

2. The dipping tanks and other areas specified in Schedule I hereto are hereby declared rabies guard areas.

Isolation and confinement of dogs in the rabies guard areas.

3. An owner of a dog in any rabies guard area shall isolate and confine it in order to prevent it from escaping from that area.

Destruction of dogs in rabies guard areas.

4. A Government Veterinary Officer may destroy a dog in any rabies guard area which, in his opinion has not been confined in order to prevent it from escaping from that area.

Presentation of dogs for inoculation.

5. A person who lives within a rabies guard area and owns a dog shall present it at the inoculation centre specified in Schedule II hereto for inoculation by the Director of Veterinary Service or his duly authorised agent during the date and time specified therein.

Offence and penalty.

6. An owner of a dog in any rabies guard area who contravenes or fails to comply with regulation 3 shall be guilty of an offence and liable on conviction to a fine of E300.00 or imprisonment for a period not exceeding six months.

THE STOCK DISEASES REGULATIONS, 1933

THE DIPPING OF STOCK NOTICE, 1985

(Under regulation 11)

In exercise of the powers conferred by regulation 11 of the Stock Diseases Regulations, 1933, I hereby issue the following Notice —

Citation and commencement.

1. This Notice may be cited as the Dipping of Stock Notice, 1985 and shall come into force on the June, 1985.

Compulsory dipping of stock.

2. (1) Subject to paragraph (2) all owners of cattle in Swaziland shall dip their cattle once every fourteen days.

(2) Owners of cattle in the Schedule hereto shall dip their cattle once every twenty eight (28) days.

Dipping hours.

3. Subject to any directions to the contrary issued by an officer authorised under regulation 11, dipping hours under regulation 2 shall be between 7.00 a.m. and 12.00 noon.

Revocation of Legal Notice No. 138 of 1984.

4. The Dipping of Stock Order, 1984 is hereby revoked.
