Citation and commencement.

Maximum Prices of Soft Drinks.

2. The maximum wholesale and retail selling prices of soft drinks shall be as set out in the Schedules hereto.

3. The Maximum Wholesale and Retail Selling Prices of Soft Drinks Notice, 1986 is hereby revoked.

LEGAL NOTICE NO. 41 OF 1987

ANIMAL DISEASE ACT, 1965

(Act No. 7 of 1965)

THE STOCK DISEASE (RABIES) REGULATIONS, 1987

(Under section 3)

In exercise of the powers conferred by section 3 of the Animal Diseases Act, 1965 the Minister for Agriculture and Co-operatives hereby makes the following Regulations—

Citation and commencement.

1. These Regulations may be cited as the Stock Diseases (Rabies) Regulations, 1987.

Declaration of rabies guard areas.

The dipping tanks and other areas specified in Schedule 1 hereto are hereby declared to be rabies guard areas.

Isolation and confinement of dogs in the rabies guard areas.

3. An owner of a dog in any rabies guard area shall isolate and confine it so as to prevent it from escaping from that area.

Destruction of dogs in rabies guard areas.

4. A Government Veterinary Officer may destroy a dog in any rabies guard area which, in his opinion has not been confined to prevent it from escaping from that area.

Presentation of dogs for innoculation.

5. A person who lives within a rabies guard area and owns a dog shall present it at the innoculation centre specified in Schedule 2 hereto for innoculation by the Director of Veterinary Services or his duly authorised agent during the time specified therein.

Offence and Penalty.

6. Every owner of a dog in any of the guard areas who contravenes or fails to comply with regulation 3 shall be guilty of an offence and liable to a fine of E300.00 or imprisonment for a period of six months.

THE INCOME TAX (AMENDMENT) ACT, 1987

(Act No. 6 of 1987)



I ASSENT

MSWATI III KING OF SWAZILAND 15th June. 1987

AN ACT

An Act to amend the Income Tax Order, 1975 ENACTED by the King and the Parliament of Swaziland.

Short title and commencement.

1. This Act may be cited as the Income Tax (Amendment) Act, 1987, shall be read as one with the Income Tax Order, 1975 (hereinafter referred to as "the Order") and shall be deemed to come into operation on the 1st July, 1986.

Amendment of section 8.

- Section 8(1) of the Order is amended—
 - (a) in paragraph (b) by replacing-
 - (i) the words "fifty Emalangeni" with the words "seventy five Emalangeni";
 - (ii) the words "three hundred Emalangeni" with the words "four hundred and fifty Emalangeni";
 - (b) in paragraph (d)-
 - (i) by replacing the words "six Emalangeni" with the words "ten Emalangeni";
 - (ii) by replacing the words "sixteen Emalangeni" with the words "twenty Emalangeni";
 - (iii) in the proviso by replacing the words thirty Emalangeni" with the words "fifty Emalangeni";

Amendment of section 14.

- 3. Section 14(1) of the Order is amended in paragraph (u)---
 - (a) by replacing the words "four hundred Emalangeni" with the words "six hundred Emalangeni";
 - (b) by adding the following sub-paragraph after sub-paragraph (ii)—
 - (iii) any sum paid to any chemist or optician for drugs, medicine or optical aids in accordance with a prescription.

Amendment of section 41.

4. Section 41(1) of the Order is amended by adding after the words "or any previous income tax law", the words "or than any amount of tax which was chargeable and should have been assessed under this Order has not been assessed".

Amendment of section 57.

5. Section 57(2) of the Order is amended by adding after the words "Commissioner's notification" the words "or as specified in this Order".

Amendment of Fourth Schedule.

- 6. The Fourth Schedule to the Order is amended in paragraph 9A-
 - (a) in subparagraph (i)-
 - (i) by deleting the words "of taxable income" and the words "of the taxable income";
 - (ii) by replacing the words "paragraph 4" with the words "paragraph 2";
 - (b) in sub-paragraphs (ii), (iii) and (iv) by replacing the words "paragraph 4" with the words "paragraph 2".
