- 2. The Act shall apply to the following human settlements and housing schemes:
 - (a) Those comprising the subdivision of land into 5 or more plots;
 - (b) Those situated on 4 or fewer plots that comprise residential uses of 50 or more dwelling units;

LEGAL NOTICE NO. 73 OF 1988

THE STOCK DISEASE REGULATION, 1933

THE DIPPING OF STOCK NOTICE, 1988

(Under Regulation 11)

In exercise of the powers conferred by Regulation 11 of the Stock Disease Regulation, 1933 I hereby issue the following Notice—

Citation.

1. This Notice may be cited as the Dipping of Stock Notice, 1988 and shall come into force on the 1st July, 1988.

Compulsory dipping of stock.

- (i) Subject to paragraph (2) all owners of cattle in Swaziland shall dip their cattle once every fourteen (14) days.
 - (ii) Owners of cattle in the Schedule hereto shall dip their cattle once every twenty eight (28) days.

Dipping hours.

3. Subject to any directions to the contrary issued by an officer authorised under Regulation 11, dipping hours under Regulation 2 of this Notice shall be between 7:00 a.m. to 12:00 noon.

Revocation of Legal Notice No. 107 of 1987.

4. The Dipping of Stock Notice, 1987 is hereby revoked.
