*“Amendment of Section 14*

- (iv) by way of contributions to an approved bursary scheme;
- (v) by way of contributions, grants or donations not exceeding E20,000.00 made to a professional body, established by law, for educational or training purposes and which the Commissioner is satisfied were paid during the year of assessment”.
