#### THE AVIATION (AMENDMENT) (NO. 2) REGULATIONS, 1988

#### (Under section 21)

In exercise of the powers conferred by section 21 of the Aviation Act, 1968, the Minister for Works and Communications hereby makes the following Regulations-

Citation and commencement.

1. These Regulations may be cited as the Aviation (Amendment) (No. 2) Regulations, 1988, shall be read as one with the Aviation Regulations, 1969 (hereinafter referred to as "the principal Regulations") and shall come into force on the 1st October, 1988.

Amendment of Regulation 153.

2. Regulation 153 of the principal Regulations is amended

- (i) by deleting the words "to aircraft" in paragraph 1(s)(i)
- (ii by deleting the words "in respect of services to aircraft" in paragraph 2(a)
- iii) by deleting the words "to an aircraft" in paragraph 2(b).
