### THE CONTROL OF CEREALS, 1959 (Act No. 28 of 1959)

# CONTROL OF PRICES OF MAIZE AND MAIZE MEAL NOTICE, 1988 (Under Section 4)

In exercise of the powers conferred by Section 4 of the Control of Cereals Act, 1959, the Minister for Agriculture and Co-operatives hereby issues the following Notice—

#### Citation and commencement.

1. This Notice may be cited as the Control of Prices of Maize and Maize Meal Notice, 1988 and shall come into force on the 1st January, 1989.

#### Interpretation.

#### 2. In this Notice-

- "bag of maize" means a unit of 70kg net weight of maize fit for human consumption and packed in a sound container;
- "burlap bag or jute bag" means a sack made of natural jute fibres;
- "plastic bag" or "polypropylene bag" means a sack made of synthetic fibres.
- "buyer" means a person who holds a licence to import maize or maize products;
- "Grade 1" means sifted granulated maize meal;
- "Grade 11" means unsifted granulated maize meal;
- "sound container" means a bag of not less than Grade 1 second hand quality.

#### Minimum price of maize produced in Swaziland.

- 3. (1) Subject to sub-section (6), a buyer who purchases maize produced in Swaziland shall pay to the producer or seller not less than E26.00 per bag of 70kg, of maize.
- (2) Producers selling maize in bags will receive the difference between the current market buying and selling price for bags, fixed at E1.12 and 97 cents respectively and the producer will recover 15 cents as a component of the gazetted price for maize and 97 cents from the buyer.
- (3) Producers selling maize in bags will be paid for the net weight of maize supplied in bags.
- (4) The net weight of a bag under this section shall be computed by subtracting the weight of the empty bag which weight has been fixed as follows—
  - (a) the weight of a burlap bag or jute bag shall be 1 kg; and
  - (b) the weight of a "plastic" or polythene bag shall be 0.150 kg.
  - (5) Sub-section 3(1), (2), (3) and (4) shall apply-
    - (a) only in the case of maize in a sound container;
    - (b) for maize of a moisture content not exceeding 12½ per centum; and
    - (c) for deliveries in lots of not less than 15 bags where the producer requires the buyer to transport the maize.

(6) Where the producer or seller delivers maize to the buyer at Manzini or any other place authorised by the buyer, the price specified in sub-section 3(1) and (2) shall be increased by the transport charges incurred by him according to the rates specified in Schedule 1.

Maximum retail selling prices of locally produced or imported maize meal.

- 4. (1) The maximum retail selling prices of maize meal in quantities of one bag or more shall be—
  - (a) Grade 1 E44.30 per bag of 80 kgs.
  - (b) Grade 2 E42.00 per bag of 80 kgs.
- (2) Subject to sub-section 4(3), the maximum retail selling prices specified in the Schedules shall apply to the sale of quantities of less than one bag of maize meal.
- (3) If a customer does not supply his own container, the following amounts, which shall not be exceeded, may be added to the prices specified in the Schedules to cover the cost of containers when maize is sold in the following quantities—

Up to -	(a)	2.3 kg.	-	1 cent
	(b)	2.3 to 4.5 kg.	-	1½ cent
	(c)	4.5 to 9.1 kg.	_	2 cents
	(d)	9.1 to 13.6 kg.	_	2½ cents
